FREQUENTLY ASKED QUESTIONS

QUESTION:

Can **SARKAR OFFICE®** help in Japan immigration (work visa) & finding a job in Japan?

ANSWER:

SARKAR OFFICE® can assist you in all immigration issues (work visas) in Japan, but do not provide any service relating to finding a job / employer in Japan. Without a job / employer we cannot assist you in the immigration issue.

QUESTION:

Can I / we get a FREE CONSULTATION / ASSESSMENT Service from **SARKAR OFFICE®** ?

ANSWER:

SARKAR OFFICE® is Legal Services firm and does not provide any FREE service. For consultation and assessment of the case you need to fill up the STANDARD SARKAR OFFICE Consultation / Assessment form, provide relevant information, pay the INITIAL consultation fee in advance.

QUESTION:

What kind of other administrative legal services does **SARKAR OFFICE®** provide?

ANSWER:

SARKAR OFFICE® provides services related to Japan Immigration, formation of company / legal entity in Japan, tax / accounting matters, social insurance, trademark registration, and other related administrative legal matters.

QUESTION:

Can **SARKAR OFFICE®** give guarantee for getting the immigration status / Certificate of Eligibility, other immigration cases (work visas) 100%?

ANSWER:

There is NO guarantee as Immigration authority takes the decision, but so far the **SARKAR OFFICE®** has handled thousands of cases for over 10 years and the success rate is 99.99% in fact 100%. So far only few cases denied are because of client's negligence in following the **SARKAR OFFICE®** advice 100% and or result from the Immigration authority investigation found faults on the client's side. **SARKAR OFFICE®** does not conduct investigation of client side (as it is not our task) but to rely on their integrity of the client's statement and documents for submission of a case.

QUESTION:

How do I proceed using **SARKAR OFFICE®** service?
